Fixed Interest Rate

This loan has a fixed rate that will not change during the life of your loan.

Eligibility Criteria

Borrower

In order to obtain this loan, you must become a member of Michigan State University Federal Credit Union. Borrower must be age of majority in state of residence at the time you apply.

Cosigners

Cosigner must be age of majority in state of residence at the time you apply.

Borrower Benefits

Interest rate discount of 0.25% for borrowers who are enrolled in recurring ACH payments. This discount is only applied for payments received via the recurring ACH process.

Bankruptcy Limitations

If you file for bankruptcy, you may still be required to pay back this loan.
